Itelyum strengthens its leadership in the **circular economy**: new acquisitions in Serbia and Croatia

Itelyum, a European leader in sustainable waste management and resource recovery, announces **two new strategic acquisitions** in Serbia and Croatia, marking a further important step in its international business growth and consolidating its central role in promoting the circular economy.

The acquisitions are:

Jakob Becker d.o.o. - Ruma (Serbia), specialised in the collection and storage of industrial waste, mainly hazardous, for local treatment and/or export to recycling facilities:

Jakob Becker d.o.o. - Gornja Vrba (Croatia), active in the management of non-hazardous waste and the recovery of materials from waste sorting.

With these operations, Itelyum is entering the markets of the Western Balkans, a region that is rapidly moving towards European standards of sustainability and environmental management. The Italian group, which already operates in Germany and France, is thus strengthening its European presence in an area with a high growth potential. At the end of 2023, the two companies employed 36 people, which will increase to 42 by 2024.

"These acquisitions represent a further step in Itelyum's mission to create **sustainable value** through the circular economy. The Western Balkans is a **strategic area** given the presence of **growing industries** and the increasing focus on sustainable development models; we are therefore proud to contribute our know-how and leading solutions to the development of the circular economy in these geographies. The newly acquired companies have a strong reputation and qualified management that will be integrated into the Itelyum Group, creating the conditions for synergies and local growth projects. Integrated industrial waste management: collection, transport, pre-treatment, consultancy and brokerage services that facilitate the sustainable re-utilization of waste.
